Achievements and challenges in

2017:

- ⇒ Initiating dialogue for key economic topics and policies;
- ⇒ Fighting against the lack of fiscal transparency on national and local level and active participation in its improvement.
- ⇒ Advocating for social and labor market inclusion of different target groups;
- ⇒ Strengthening the civil society and networking for greater civic causes;
- ⇒ Providing quality analyses and recommendations relevant for improved public policies;
- ⇒ Building capacities of different stakeholders and target groups.

Highlights from 2017:

- ⇒ Urgent need for democratic reforms that aim to restore democratic standards and values in Macedonia and to restore and increase trust in key state institutions.
- ⇒ Need of greater public awareness about the work of the State Audit office, and the need for urgent action following the recommendations of this supreme institution.
- ⇒ Need of open expert discussion on key economic topics, such as topics that <u>CEA initiated</u>: Sustainability of the pension system; Foreign investments; the GDP fetish; Rule of Law debate; Emphasized the need for more efficient public finances and monitoring of the public finances fulfilment of actions from the Blueprint and from the Government 3-6-9 Plan.
- ⇒ The social inclusion and employment are facing a serious challenge with continuous high rates of long-term unemployed, youth unemployment, lack of properly designed social care and unsatisfactory education level.
- ⇒ Continuous need for increased budget and fiscal transparency, accountability and public participation.

What is fiscal transparency?

Openness to the public about the structure and the function of the local / central government, the intentions on the fiscal policies, the accounts of the public sector and the fiscal projections.



⇒ Fiscal Transparency & Accountability

Why improved fiscal transparency?

Budgets are the most powerful tool to meet the needs and priorities of the state and its citizens. The transparency of the budget is prerequisite for the participation of the citizens in making decisions on spending public funds and accountability of the authorities.

Strengthening Financial Accountability & Transparency in Macedonia

CEA in partnership with the Westminster Foundation for Democracy are working toward increasing the level and quality of financial and budgetary oversight in Republic of Macedonia by fostering cooperation between independent regulatory bodies and the Parliament.

During 2017, we built a solid partnership with the SAO and encouraged the public for greater interest in how their money are spent, and at the same time to encourage them to make pressure to the authorities by referring to the recommendations from the SAO's audit reports.

In the past year, we developed 4 quarterly reports based on the monitoring of SAO's work, and the awareness of the stakeholders about the SAO's work, which were publicly presented. Also, we were working on building the capacities of the media for understanding the audit reports. If interested for more, please follow the <u>link</u>.

Analysis on the Proposed Budget 2018

Based on its expertise, CEA was invited by the Westminster Foundation for Democracy, to develop analysis on the <u>Proposed Budget 2018</u>, compared with the Proposed Budget 2017. The analysis was developed to serve mainly the MPs, during the discussions in the Assembly before enacting the Budget, and further for the media and other interested stakeholders.



⇒ Fiscal Transparency & Accountability

Fiscal transparency at local level

CEA implemented the project: "Degree of transparency of the municipal budget process in Macedonia", which the main aim was: Determining and improving the level of transparency of the budget process and accountability in the spending of public funds in the LSGU.

The general objective was reached trough determining the degree of transparency through the availability of basic budget documents in all 80 LSGUs, and trough increasing awareness and knowledge of the importance of transparency and accountability the budget process and the spending of public funds among the citizens and the civil sector by presenting the situation.

Partnership for Open Budget Survey & Budget Tracker

CEA continues to be a partner with the world renowned International Budget Partnership-IBP in the process of implementing the Open Budget Survey for Macedonia. In that line, CEA monitored the government openness for the period 2015-2017.

The results from the last Open Budget Survey were presented on a national conference for Open Government Partnership in Skopje. <u>Link</u> of the last OBI Report for 2015. The new OBI results will be published on January 30, 2018.

Open Government Partnership

In line with the CEA's mission to improve the accountability of the authorities, starting from 2016 CEA participates in the working groups of the Open Government Partnership. CEA proposed several measures for improving the transparency of the Government, and all of them were accepted in the OGP Action plan 2016-2018. ⇒ Socio-Economic Prospects and Challenges

Creating employment pathways for rural youth

"Creating employment pathways for rural youth" is a CEA and FFRM partnership undertaking. The project was supported by European Commission and its aim was to facilitate the social inclusion of rural youth through the labor market in the Northeast planning region of Macedonia. This overall objective was achieved through:

- 1) increasing the employability skills of rural youth,
- 2) establishing a regional workforce system and
- 3) developing a regional strategy for social inclusion through the labor market of the target groups.

Employment for Roma Youth

CEA, together with the partner organizations Svetla Idnina, Sumnal and Sonce, during the 2017 implemented the project "Employment for Roma youth" funded by the European Union through the IPA Human Resources Development Program.

The main object was to facilitate the labor market inclusion of Roma youth living in the municipalities with significant Roma population facilitating the involvement of young Roma living in municipalities with significant Roma population. This goal was achieved through the project goals; 1) improving the skills and understanding of the employability of young Roma; 2) providing a local development system that will network the market needs; and 3) develop a strategic guide to social and market inclusion target groups.

⇒ Socio-Economic Prospects and Challenges

Entrepreneurship policies in Macedonia for overcoming Roma "othering"

CEA in partnership with IRIZ organized a conference based on the implemented project "Entrepreneurship policies in Macedonia for overcoming Roma othering." The project was focused on three distinct levels where "fear, the security mindset and "othering" of Roma" happens: politics, policy and public discourses.

Through a fellowship and mentoring a young Roma researcher, the two partner organizations reviewed and analyzed the existing policies for socio-economic inclusion of Roma in Macedonia and conducted a unique situation analysis identifying the links between entrepreneurship and "othering" in Macedonia. Civil Society for Roma Integration - In the Shadow

CEA and its partner organization Romalitico, supported by the TTF and RIO, are implementing the project "Civil Society for Roma Integration-In the Shadow" which aims to develop a shadow report as a review of progress noted by the country on implementation of the National Roma Strategy (and the NAPs), and to lead continuous evidence based advocacy for a change in the transition period from a "passive" job seeker to an active seeker and potential budget alteration.

The expected outcomes of the project are the following: External assessment of fulfillment of the obligations to promote Roma inclusion in the NRS for 2016; Potential alteration in the transition period from a "passive" job seeker to an active seeker and potential and budget alterations; Increased awareness of the potential users of the state measures.







Decentralized civic initiatives for more efficient fiscal decentralization

Focusing on the need for enhanced civil society with active and strong civil society organizations throughout the country with decentralized actions, CEA is working on decentralized civic initiatives for more efficient fiscal decentralization. Supported by the CIVICA Mobilitas Program the action aims to identify the causes and the extent of regional development of the civil initiatives in order to contribute to a more effective fiscal decentralization and balanced regional development of the civil society.

During the 2017, CEA conducted comprehensive research for identification of the needs and determinants of civil society necessary for an effective participation in local policy decision-making CEA believes it will contribute to a greater decentralized CSO impact on improved regional development of the CSO sector. Determinants of influence of CSOs in creating policies for balanced regional development

Supported by the British Embassy and in partnership with FORUM CRSD, CEA developed analysis on the "Determinants of influence of CSOs in creating policies for balanced regional development".

In this analysis, CEA covered one important segment of functional parliamentary democracy, and it is the cooperation of civil society in the regions and regional characteristics of civil society. Manual for Mayors and Members of the Municipal Councils

Supported by Civica Mobilitas program, CEA is implementing a project which aims to: Increase the capacities of the new leading structures in the municipalities for efficient and effective implementation of the competences and increase the awareness of the citizens for monitoring the work of the municipalities.

⇒ Improving Civil Society

Blueprint for urgent democratic reforms

CEA was one of the initiators of the core group of civil society organizations and experts for preparation of the Proposal for urgent democratic reforms with an aim to return to democratic standards and values in Macedonia, and restoring trust in key state institutions.

CEA contributed in the section for public finances and economy for restoring fiscal discipline and establishing the fiscal transparency.

Public Finance and Economy - GENERAL PRINCIPLES

- ⇒ Restoring fiscal discipline;
- ⇒ Increasing fiscal transparency;
- ⇒ Prioritizing ongoing public projects;
- ⇒ No changes in the public finance system structure (any changes in the public finance system should be left for the future government that received its mandate through elections).

CEA also, monitored the implementation of the recommendations contained in the Blueprint, and the implementation of the governmental plan 3-6-9, and publicly presented its views. See more about the initiative <u>here</u>. The review of the implemen-

Regulatory Impact Assessment - In shadow

CEA in partnership with IDSCS is implementing a project, supported by the EU, which aims to analyze how the process of RIA is being implemented while drafting the laws and what are the possibility for civil society organizations to be engaged in creation of public policies in Macedonia.

We are working toward increasing the possibility for active involvement of CSOs in the RIA process and in public policy reforms through networking, inclusive consultations and trainings. The project pays particular attention to creating links between civil society actors and state institutions. Good implementation of RIA will contribute to higher quality of legislation, increased citizen involvement, increased level of legal certainty, better financial planning and increased transparency of political processes. International event -Rule of law, Where are we heading?

CEA organized international event "Rule of law, Where are we heading?" that brought together representatives from academia, think tanks, civil society and policy-making to take stock of where we are today and we are heading when it comes to the Rule of Law in Europe.

The Event was co-organized by the Centre for European Policy Studies (CEPS) in Brussels, with the full involvement of the five selected members of the ENGAGE Fellowship.

The various debates underlined the importance for the EU to have a clear, value-based and frank strategy in the Western Balkans. Various participants, including high level government representatives, high-lighted their willingness to make the EU accession process more concrete and political. The discussions concluded that the needed changes in one country, will always have to be achieved through a Rule of Law based approach, safeguarding the values of democratic and judicial accountability and human rights. Sustainability of the pension system in the country

The Center for Economic Analyzes (CEA) held a presentation on the analysis of the sustainability of the pension system in Macedonia.

The analysis sparked considerable interest from the media, especially for the following conclusions:

"The first pillar of the pension fund by 2030 will not only crash as predicted by the IMF, but will itself be maintained and will create surpluses. So, it should be considered as a Pension Fund that anywhere from 2025 will begin to generate surpluses, and the state will not need to allocate money to fill the pension budget. It should be also considered whether the Fund will be sold or a special investment fund will be set up that will invest the money that will be redundant. "

Gross Domestic Product – GDP Fetish

In December, CEA conducted analysis on the current economic development in the country. The findings were publicly presented, with participation of public institutions' representatives.

This analysis was developed to indicate that the Government despite using the GDP, should start using another metrics for economic development and progress in order to more effectively adapt its agenda to the needs of the citizens.

Also, the analysis is developed to initiate expert discussion and to indicate the relativeness of some indicators for economic development, such like GDP is. More information can be found here.

First CEA Journal was issued in 2006. Starting from 2012 CEA Journal of **Economics** become international journal, indexed in <u>EBSCO</u> and <u>EconLit</u> databases of journals.

The journal enables a platform for economic forum where economists practice technical quantitative and qualitative analyses of economic problems and to enrich the public debate on economic issues in Macedonia and the region. During the 2017, CEA was awarded for several achievements::

- ⇒ **Gratitude from MASA**: On the occasion of the 50th anniversary of the foundation of the Macedonian Science of Science and Art (MASA), the Center for Economic Analyzes (CEA) received a Gratitude for longstanding cooperation. Center for Economic Analysis and the Center for Strategic Research, as a unit of MASA have signed a cooperation agreement on themes of common interest.
- ⇒ Marjan Nikolov, President of CEA, was appointed for Ambassador of the Regional Studies Association (RSA) for Macedonia in June 2017 in the next 3 years. RSA, with its international membership, works to facilitate the highest standards of theoretical development, empirical analyzes and policy debates, on questions of this type of sub national scale, including urban and rural as well as other different concepts of space as city regions.

- Four trainings for Soft Skills, Communication, Job Seeking, Entrepreneurship and Fund Raising for the unemployed Roma youth from the municipalities with dominant Roma population.
