- 1. There is no formal charge to attend this event but a voluntary donation to RSA Europe of €250 is strongly encouraged to support the Foundation's work.
- 2. Acceptance to the College covers accommodation, meals during the conference and the social activities listed in the Summer College program.
- 3. The organisers cover 4 nights' accommodation: (check-in: Monday, 2nd September afternoon; check-out: Friday, 6th September morning). The local organisers have booked accommodation at the University Guest House or Hotel "La Terrazza" (TBC).
- 4. Please note that you may be allocated a shared double room.
- 5. Notification of cancellation must be given by email and received by the Regional Studies Association before 1st August 2019.
- 6. Any late cancellations are strongly encouraged to subsidy their costs of attendance via donation.
- 7. Substitute participants will be accepted a name and details will be required in advance.
- 8. Shared places are not permitted.
