Naked and Plastic Free Journals

RSA is going naked and plastic free with its journals. What does this mean? Well in short, it means we are removing all plastic lamination from the covers of our journals and will begin sending our journals to members still receiving the printed copy without a plastic covering.

We thank our publishers, Routledge, for instigating changes to their production and despatch systems that allow us to benefit from this. The Association has long had a policy addressing our own sustainability and climate change impacts. As a small

organisation we can only make relatively minor changes, but cumulatively these do add up and the removal of plastic from publishing processes will have a substantial impact in the round.

What is the current position?

All RSA members have the choice of receiving both print and online copies of three of our hybrid journals. Regional Studies, Regional Science is gold open access and only available online. Area Development and Policy is currently sent in a single annual volume to all members. This is because it's still a relatively young journal and we are seeking to raise the profile of the work that it publishes. ADP's focus is on the wider BRICS (Brazil, Russia, India, China, South Africa) and allows researchers to write in their own territorial voice with their own local customs and traditions. By sending this journal in print to all our members we hope to expose these legitimate but sometimes non-Western ways of working to a wider, curious and accepting audience.

Pandemic Effects

At the beginning of the Covid pandemic we rapidly became aware that many members were separated from their journals which were posted to their offices. We made it possible to easily change delivery addresses but also to access the content online with all the advantages of searchability. As a result, many members took the decision to drop print altogether.

Although this is great for the environment, it runs the risk that members become out of touch with the journals and for this reason the RSA Board has decided to send journal alerts to all members. These are short click through emails produced by the publisher to alert readers to new content. Because we publish five journals, in 25 issues and articles for RSRS stream online when ready, this could mean 30 or so emails a year and so we've ensured that members will be able to easily unsubscribe to this service. The advantage of it is that our members won't miss a key article in their field and will receive prompts rather than needing to remember to check the portal.

What to expect going forward?

All our print journals are switching as fast as possible to unlaminated plastic free covers. The high gloss finish will go and the covers will still have a sheen but may scratch more easily.


The journal will ship as it is – naked. There will be no wrapping on it at all and the back cover will be used to carry the shipping information such as name and address. The information formerly on the back cover moves to the inside of the journal.

Across their portfolio, our publishers have been using biodegradable polywrap for some time, in fact, over three million a year (approximately the weight of six cars). They have also printed 3.3 million laminated journal covers and this plastic is not fully degradable and is not consistently or effectively recycled.

We have been working with Taylor and Francis (owners of the imprint Routledge) to test the receipt of journals produced in this way and we are confident that the quality of the received journal is sufficiently high and the gain is significant for the environment.

The RSA Publications Committee and Board believe this move is both timely and important and we are proud to be living up to our values of being a "leading" and "impactful" for our "community" in making this change.




Crest Seminar Series

The final session of the inaugural *Cities, Regions and Sustainability Transitions* (CReST) webinar series took place on 25th March, with talks from David Gibbs, Kirstie O'Neill, Markku Sotarauta and Nina Sauvinen on the theme of *Enterprise and Leadership for Green Economic Development*. The series stimulated discussion and debate about ways forward for understanding economic geographies of sustainability transitions, bringing together perspectives from academic, policy and practice. It also sought to provide opportunities for people at different career stages to present together, providing a stage for rising stars as well as established supernovas.

Over the course of the series we focused on a range of critical issues for understanding the potential, possibilities and politics of urban and regional sustainability transitions. This included session on: the role of the state in mediating regional sustainability transitions; innovation geographies of sustainability transitions; financial geographies of sustainability transitions; path creation for sustainability transitions; and equity, justice and sustainability transitions. The webinars attracted speakers and attendees from across six continents (but no one from the Antarctic made it along unfortunately) and over 35 countries.

The <u>series</u> was organised by Laura Norris (Cardiff University) and <u>Will Eadson</u> (Sheffield Hallam University) and will be continuing in Autumn 2021; in the meantime the debates will be continued in a special session on geographies of transition at the Regions in Recover Festival in June.



FinGeo Seminars - Series 1

The Global Network on Financial Geography – FinGeo for short - is an open and interdisciplinary network of academics, practitioners and experts interested in research on the spatiality of money and finance and its implications for the economy, society, and nature. As one way to build active collaborations among its community it collates and disseminates research in a variety of forms including blogs, working papers as well as a highly successful and popular spring school and workshop.

In 2021 it launched a <u>Virtual Seminar Series</u> in association with the Regional Studies Association. Each series consists of 5 or 6 seminars over 2 months and covers a range of topics and approaches to Financial Geography, with presentations from experienced researchers, early career researchers and everyone in between.

The first series was a great success and covered topics from remittances in Senegal and Ghana; housing in Brazil and elsewhere in South America; to the rise of Regulatory Capitalism; a discussion of financial centres in investment banking; and, topically, Debt in the time of Covid.
