

New RSA Mobile App launched!



Key features include:

- Reflowable text that automatically adjusts according to your device
- Adjustable font size and page layout options allows you to personalise your reading experience to suit your own preferences
- Offline reading and EPUB download options allow articles to be saved and opened with any EPUB compatible device or App such as Apple Books or Google Play Books.
- EPUB files up to 90% smaller than PDF files meaning faster download times and

more efficient data usage for mobile users











If an article has an EPUB version available, the article page will display the 'PDF | EPUB' button in place of the standard 'PDF' button. Clicking the 'PDF | EPUB' button will open the eReader by default. If you wish to download the PDF you may do so from within the eReader by using the switch format or download options.





This thought-provoking book questions the framework of the Horizon 2020 strategy and the policies of smart development. It aims to answer the following question: Is there any possibility



for a policy of smart development and smart specialization in rural and peri-urban areas?

Based on detailed analytical studies, empirical and econometric methods, as well as various European case studies, several conclusions are drawn. These are important in that they question the validity of the H2020 policy, smart development and smart specialization policies, and their applicability to the whole European area, and not only for the most urban and rich areas. It will be valuable reading for students, researchers and policy-makers in regional development, rural studies, spatial planning and economic geography.
