

[Event News: The RSA Women's Network Event](#)

“The art of career friendly decision-making” or in other words “When to say yes, and when to say no?” was the topic of the 5th Networking Workshop for Early and Midcareer Women in Regional Science and Regional Studies, organised by the RSA’s Women's Network. With around 50 participants attending this virtual workshop, we were delighted to welcome so many familiar, and so many new faces. Prof. Jennifer Clark (Ohio), Prof. Tuna Tasan-Kok (Amsterdam), and Dr. Mia Gray (Cambridge), three high-level academics from very different institutions, shared their own experiences about when to say yes, when to change course, or when to say no to proposed tasks and requests. While they agreed that each career is individual, and circumstances differ across countries and institutions, all three also agreed on some important aspects. A key example was how they all decided to take paths following high standards of integrity and honesty, even when sometimes this was the more difficult option.

The workshop was very dynamic and created a supportive environment, providing the RSA with an ever more growing network to further live up to the “No-Smurfette-principle”.



A new book has recently been published [The Urban Planning Imagination: A Critical International Introduction](#) by our RSA member, Nicholas Phelps. In it, Nicholas explores the key themes and driving questions in the circulation of planning ideas and methods over time and across spaces, identifying the contrasts and commonalities between urban planning systems and cultures. He argues that the tools for inclusive urban planning are today, more than ever, not solely restricted to the hands of planning bodies, but are distributed across citizens, a variety of organizations (what he calls 'clubs') and states. As a result, the book sets the ground for the new arrangements between these groups and actors which will be central to the future of urban planning.



- This Grant supports a discrete piece of regional studies and/or regional science research on the impact of the COVID-19 on regions, cities and industry.

- Research can cover economic, environmental, social, political, cultural aspects, behavioural and/or technological change.
- It could address conceptual, methodological, empirical or policy impacts. Topics can be specific countries, regions or cities, providing there are wider implications for global audiences.
